## Qualification for Corporate Memberships

The Corporation must be a for profit organization and have been established for at least one (1) year. For verification purposes the club reserves the rights to conduct further inquiry on behalf of the organization/corporation. The BERWICK GOLF CLUB Board of Directors also reserves the right to decline any applicant that does not meet the intention of said membership. The corporate memberships are not intended for a sole proprietor business nor an individual who may be employed by a corporation.

## Corporate Golf Membership Level Details:

### EAGLE

Membership will be issued in the name of the organization/corporation and will be assigned to a particular designee who must be an employee or a member of the Board of Directors of said organization/corporation. Designee cannot hold elective or appointive office and may not own voting stock.

An initial opening deposit of \$3,750.00 and a \$250.00 first year administration fee will be deducted upon which \$150.00 admin fee each year following. The corporation can designate up to 4 users on the account. All charges will be deducted from the credit balance. When the account falls below \$750.00, the corporation will be asked to deposit another \$3,750.00 into the account.

No charging privileges or credit will be granted to this membership. The users will only be able to use the credit balance available. All users in this membership will be charged the predetermined greens fee and cart fee every time they golf.

All food and beverage purchases will also be deducted from the available balance. A non-user/guest of the corporation may only play three (3) times and all charges will be deducted from the available balance.

Payment for the Eagle Corporate membership must be with the Corporation check in which the name of membership is issued.

**Application Fee:** \$250(1st year); \$150 (re-occurring annually)

**Dues:** \$3,750.00 (initial fee and \$3,750.00 after account drops below \$750.00)

**Food Minimum:** None

## BIRDIE

A corporation/organization elected to clubhouse privileges and may utilize golf privileges of 40 rounds with a golfing pass and a 10-round play limit per person. Golfing passes are valid only within the current fiscal year. Membership will be assigned to a particular designee. **A non-user/guest of the corporation/organization may only play three (3) times and all rounds will be deducted from the available balance of rounds.**

Membership cannot be combined with any other club membership.

**Dues:** \$1,600.00 (one-time fee – carts included)

**Food Minimum:** None

## PAR

A corporation/organization elected to clubhouse privileges and may utilize golf privileges of 20 rounds with golfing pass and a 10-round play limit per person. Golfing passes are valid only within the current fiscal year. Membership will be assigned to a particular designee. **A non-user/guest of the corporation/organization may only play three (3) times and all rounds will be deducted from the available balance of rounds.**

Membership cannot be combined with any other club membership.

**Dues:** \$800.00 (one-time fee – carts included)

**Food Minimum:** None

No Food Minimum, No Assessments

You do not have the option of owning stock; therefore, you have no voting privileges.

Restrictions:

Corporate golfers cannot play in the Men's or Women's Club Championships.

Corporate Golfers can only play in the Men's or Women's Member/Guest if they are invited as a guest.
